



## REGULATIONS OF THE

### "THE VREDESTEIN 20KIDS DE PARIS

#### EDITION 2024

*This document is a translation into English of the French document "Règlement des Vredestein 20 kids de Paris". It has been prepared for the convenience of non-French speaking beneficiaries. Should any question arise about the interpretation of these rules, the French document will be the reference.*

These regulations apply, without restriction or reservation, to all participants in the Vredestein 20kids de Paris event.

The main characteristics of the event are presented on the website:

The participant is obliged to read them before registering.

The participant declares that he/she has read and accepted these regulations.

#### Art. 1: PLACE, DATE AND NATURE OF THE COMPETITION

The "Vredestein 20kids de Paris" is a discovery event which is not subject to any ranking and whose objective is to introduce children to running and solidarity.

The event will take place on Saturday 12 October 2024.

The course of the "Vredestein 20kids de Paris" will be defined in the vicinity of the "Vredestein 20km de Paris" race village.

#### Art. 2: ORGANISER

Under the aegis of the Mairie de Paris and with the support of the Préfecture de Police de Paris, the 5<sup>th</sup> edition of the "Vredestein 20kids de Paris" is organised by :

### Art. 3: CONDITIONS OF PARTICIPATION

Participation in the event is conditional on :

#### A- Age category

The event is open to runners from 6 to 13 years old: born after 12 October 2011 and before 13 October 2018.

Depending on their age, they will participate in an event that is adapted in terms of distance:

- 6 - 9 years (born after 12 October 2015 and before 13 October 2018) : 1,000 m
- 10 - 13 years (born after 12 October 2011 and before 13 October 2015) : 2,024 m

#### B- Parental consent

A parental authorisation signed by one of the parents or a legal representative must be provided to the organisation so that the child can participate in the event corresponding to his/her age.

#### C- Registration fee

The registration fee, which includes participation in the event, the souvenir t-shirt and the finisher's medal is:

- €15 including VAT

The registration fees are to be paid in cash, in full, on the day of registration on the Njuko registration platform in favour of the Association Club des 20 km de Paris.

An amount of €3 will be donated to charitable causes.

#### D- Bib

The participant must visibly wear the race number provided by the organisation on the front of the T-shirt at chest level during the entire event.

### Art. 4: REGISTRATIONS

Registration takes place on the "Vredestein 20 km de Paris" website which uses the Njuko platform, technical service provider of the Association Club des 20 km de Paris.

For this purpose, participants must complete a registration form and accept unconditionally these race regulations.

Participants undertake to provide only truthful information.

Payment is made by secure payment, on the Njuko platform by bank card (Visa, MasterCard, ...)

Payment by bank card cannot be refunded, except in the event of fraudulent card use. In this case, participants may request the cancellation of the payment and the return of the sums in question.

Payments made by participants will only be considered final after the actual receipt of the amounts due.

All registrations are firm and final, and fees cannot be refunded for any reason whatsoever.

**Important:** Any application submitted other than by this site or through sites accredited to offer registrations for our events (e.g. by email, post or hand delivery) will not be considered.

#### Art. 5: COLLECTION OF THE RACE NUMBERS

Participants will be able to pick up their race number and prize money at the “Vredestein 20km de Paris” race village at the times indicated in the registration confirmation.

Prohibition on transferring race numbers:

All entries are personal, firm and final. No transfer of registration is authorised for any reason whatsoever. Any person who transfers his or her number, even free of charge, to a third party will be held responsible in the event of an accident occurring or caused by the latter during the event. The organisation declines all responsibility in the event of an accident in this type of situation.

However, it is possible to transform a registration for the Vredestein 20kids de Paris in person into a registration for the Vredestein 20kids de Paris online without any additional costs or reimbursement upon request of the registered runner.

#### Art. 6: SPORTS REGULATIONS AND CODE OF CONDUCT

##### A- Support for participants

All external assistance is forbidden.

##### B- Follower

No follower is allowed, under penalty of disqualification.

##### C- Headphones

Headphones or earpieces are allowed but remain the responsibility of the runner. However, for obvious safety reasons, the organisers strongly advise against the use of headphones that may interfere with listening to one's own environment during the races.

#### D- Code of conduct

The competitor undertakes on his honour not to anticipate the start, to cover the full distance before crossing the finish line and to ensure that his number, placed on his chest, is fully legible during the event.

#### E- Exclusion from the event

Participation in the Vredestein 20kids de Paris is forbidden to all wheeled vehicles, except those belonging to the organisation or accepted by it, as well as to animals. Similarly, it is forbidden to bring any dangerous or illegal object onto the event site.

The Association Club des 20 km de Paris reserves the right to exclude any person who contravenes these principles, without being held responsible or liable.

In general, any behaviour that may be detrimental to the smooth running of the event and/or the safety of participants may be penalised by exclusion from the event.

#### Art. 7: PROTECTION OF THE ENVIRONMENT

Any abandonment of equipment or dumping of waste outside the designated areas will result in the exclusion of the offending competitor from the event.

#### Art. 8: INSURANCE

The organisers shall take out insurance covering the consequences of their civil liability and that of their employees. Proof can be provided to any participant who requests it. This guarantee will come into play in addition to, or in the absence of, other insurance policies that may be in force.

It is strongly recommended that other participants take out personal accident insurance, covering any physical injury to which they may be exposed as a result of their sporting activities.

The organiser declines all responsibility for any damage (theft, breakage, loss, etc.) to participants' personal property, even if it is in his custody. Participants will not be able to claim against the organiser for any damage caused to their equipment. It is the responsibility of the participant to take out insurance to cover these risks.

#### Art. 9: SAFETY AND MEDICAL CARE

Road safety and medical safety adapted to the number of participants and the duration of the event are ensured on the course. The health services may decide to stop a participant for medical reasons.

#### A- Pathways used

The event takes place on roads not open to traffic, but participants must follow the course.

#### B- Safety of participants

The "Rescue" system set up is provided jointly by the Protection Civile Paris Seine and the SAMU. This system is subject to the approval of the Préfecture de Police de Paris.

It may be decided by the "Rescue" team to stop a participant for safety or medical reasons, without the responsibility of the Association Club des 20 km de Paris being engaged or sought.

#### C- Locker area

There is no locker area where the competitor can leave his change bag. Each parent will be responsible for keeping their child's change of clothes.

#### Art. 10: IMAGE RIGHTS

By registering for the Vredestein 20kids de Paris, the minor participant, with the agreement of his/her parents or legal representative, expressly authorises the Club des 20 km de Paris association as well as its beneficiaries (such as partners and the media) to use or have used or reproduced his/her name, image, voice and sporting performance in the context of the sporting event with a view to any direct or derivative use of the event and this on any medium, throughout the world, by all means known or unknown to date, and for the entire duration of the protection currently granted to these direct or derivative uses by the legislative or regulatory provisions, the judicial and/or arbitration decisions of any country as well as by current or future international conventions, including for any possible extensions that may be made to this duration.

This authorisation is given without financial consideration and remuneration for the use of the images.

The Association Club des 20 km de Paris expressly refrains from using the photographs in any way that might infringe on the private life or reputation of the participant, and from using the photographs that are the subject of this authorisation in any way that might cause prejudice to the participant.

## Art. 11: PERSONAL DATA

### Data collected

By registering for the Vredestein 20kids in Paris, the competitor is required, with the consent of his/her parents or legal representative, to provide a certain amount of data and information, in particular during the registration procedure. This data makes it possible to identify the participant, directly or indirectly, and may be considered as personal data within the meaning of the applicable regulations on the protection of personal data.

In general, personal data, communicated by participants with the agreement of their parents or their legal representative, are intended for use by personnel authorised by the Association Club des 20 km de Paris, who may be members of the Association or a service provider responsible for processing this data (number printer, registration manager, communication agency, etc.).

The Association Club des 20km de Paris collects this data for specific purposes, in accordance with applicable legal provisions and with the participant's consent, and for the purposes of:

- Allow the creation, management, and access to the participant's account.
- Provide the information and options chosen.
- To enable the processing, follow-up, and management of the participant's registrations for the various editions of the Vredestein 20kids in Paris.
- Combat fraud.
- To enable the management, modification of the services offered by the Association Club des 20 km de Paris.
- Send emails or messages to provide the participant with any useful information such as order confirmation, updates, newsletters from the Vredestein 20 km of Paris, ...
- Send emails or SMS to the participant to provide information, announcements, and updates about the Vredestein 20kids in Paris.
- Collect information, including through surveys or questionnaires.
- Ensure compliance with applicable legal and regulatory provisions.
- Send emails or SMS to inform the participant of other events; partners that may be of interest.
- To enable the marketing management and promotion of the services offered by the Association Club des 20km de Paris.
- To send emails or SMS, to communicate promotional offers, advertisements, or other commercial communications from partners.
- Organise lotteries and competitions and allow the participant to register and participate in them.
- To enable any other purpose specified at the time of collection of the Data.

### Opposition

If a participant, with the agreement of his/her parents or legal representative, wishes to object to such publications, he/she must communicate this decision to the Association Club des 20 km de Paris at the address [rgpd@20kmparis.com](mailto:rgpd@20kmparis.com), before the event and at the latest thirty (30) days before the event, so that the appropriate measures can be taken

### Data Sharing

The Association Club des 20km de Paris may share data about participants with third parties.

Finally, the Association Club des 20 km de Paris may share data with its suppliers, service providers, subcontractors or members of the association who are responsible for certain tasks on its behalf. For example, these suppliers may be the registration manager, the manufacturer of race numbers, the company in charge of medical assistance. These partners have agreed to maintain the confidentiality, security, and integrity of the data.

The data is hosted in France.

By telephone call and/or postal mail or by e-mail or SMS, the participant is likely to receive promotional offers from commercial partners if he/she has ticked the box provided for this purpose when ordering. The data is never transferred or sold by the Association Club des 20 km de Paris to third parties.

In any event, the participant, with the agreement of his/her parents or legal representative, may at any time object to this under the conditions set out below.

Pursuant to the law of 6 January 1978 relating to information technology, files and freedoms, reinforced and completed by the RGPD (General Data Protection Regulation) and modified by law n°2018-493 of 20 June 2018, the participant has the right to query, access, rectify and oppose for legitimate reasons all data concerning him/her, as well as a right to oppose commercial prospecting by the Association Club des 20 km de Paris and/or its commercial partners. The participant also has the right to formulate specific or general directives concerning the conservation, deletion and communication of his or her data postmortem.

Applications will be considered as soon as possible.

The participant may also unsubscribe from the newsletters by going directly to the bottom of one of the newsletters he/she receives. Requests will be processed within a maximum of 48 hours - 2 working days - except for requests sent by post, which require a period of 8 days.

### Art. 12: FORCE MAJEURE

In the event of force majeure, notably and without this list being exhaustive, in the event of a climatic event, natural disaster, changes in health restrictions or any other circumstances which endangers the safety of participants, the Association Club des 20 km de Paris reserves the right to cancel the race. Participants will be informed by all possible means and must then strictly comply with the directives of the organisation. Failure to comply with these instructions will de facto end the responsibility of the organiser. The participant will not be entitled to any reimbursement or compensation in this respect.

### Art. 13: CANCELLATION

The organiser reserves the right to cancel the event at any time:

- or at the request of the administrative authority,
- or if the administrative authorities do not authorise the event,
- or in case of force majeure (bad weather, too few participants, total or partial confinement... ).

In this case, all those registered for the Vredestein 20kids event in Paris will automatically be registered for the online version of the event at no extra cost.

No refunds or partial refunds will be given for cancellation of the event.

### Art. 14: ABSENCE OF RIGHT OF WITHDRAWAL

Note that in accordance with the provisions of Article L221-28 of the Consumer Code: “The right of withdrawal may not be exercised for contracts (...) of leisure activities which must be provided on a specific date or period; (...)”

Given the nature of the services provided, participants do not have any right of withdrawal.

The contract shall therefore be definitive on registration in accordance with the procedures specified in these rules.

### Art. 15: DISPUTE

Any claims for an amicable settlement must be made in writing to the organiser at the following address:

Such requests must be accompanied by a stamped envelope for the reply, prepared with the name and address of the addressee, within 30 days of the run.

Any disputes must be brought before the competent court.

### Art. 16: ACCEPTANCE OF THESE REGULATIONS

Participants fully agree to these rules.

Registration constitutes unconditional acceptance of these rules.



These rules may be subject to subsequent changes, the version applicable on the day of the race.

**Art. 17: PRE-CONTRACTUAL INFORMATION - ACCEPTANCE OF THE PARTICIPANT**

The Participant acknowledges having been informed, prior to registration and the conclusion of the contract, in a legible and comprehensible manner, of these regulations and of all the information listed in article L. 221-5 of the French Consumer Code, and in particular the following information:

- the essential characteristics of the services offered, taking into account the communication medium used and the service concerned,
- the price of the services,
- information on the identity of the organiser, its postal, telephone and electronic contact details, and its activities, if not apparent from the context,
- information on the absence of withdrawal,
- the means of payment accepted.
